

# OSHA Forklift Training Class and Refresher

OSHA's \*mandatory compliance standard for the new forklift training rule is now in effect. Forklift operators frequently underestimate the damage that can be caused by careless operation of their units. Death, serious injury, damage to building, damage to stock and forklift damage have all been documented on a regular basis over the years. Since operating a forklift can be hazardous, \*OSHA now requires that all workers who operate power lift devices receive training in the use of these units at least every three years. The new forklift training rule states that, regardless of an operator's performance, refresher training must occur every three years.
